**Nature Encounters Tours & Travel Ltd. accepts bookings subject to the following terms and conditions:**

**1. The Contract** - All persons (the guest) wishing to make a booking must sign the booking form and release. The contract is between Nature Encounters Tours & Travel Ltd. and the guest, being anyone traveling or intending to travel on a tour operated by Nature Encounters Tours & Travel Ltd.. The service to be provided is the tour(s) referred to in the booking form. This contract and all matters relating to it are subject to the laws in the Province of Alberta and British Columbia and the exclusive jurisdiction of the courts in the Province of Alberta and British Columbia, Canada. No one other than a director of the company has the authority to vary or omit any of these terms and conditions.

**2. Payment/Acceptance of Booking** - The booking form must be completed and submitted along with a non-refundable deposit according to the payment schedule on the front page of this form. Guests booking by telephone, facsimile or internet/e-mail are deemed to have read the booking terms and conditions and to have signed the Release and Assumption of Risk. Clients may be required to complete a supplementary medical form. Once the booking is confirmed, Nature Encounters Tours & Travel Ltd. will notify the guest or their travel agent by fax or e-mail at which point a contract as described above comes into existence.

**The balance of the tour price is due 75 - 90 days prior to departure. Your final payment date is on page 1 of this form.**

A booking made within 75 days of trip departure requires full payment at the time of completing the booking form. The date that written confirmation is received by Nature Encounters Tours & Travel Ltd. will be recognized as the cancellation date. The following cancellation penalties will be applied:

**All payments for tour (land portion) is non-refundable**

**Airline deposits will be subject to penalties and will sometimes be 100% non-refundable**

**3. If We Cancel the Tour** - Nature Encounters Tours & Travel Ltd. reserves the right to cancel a tour in the event that a minimum number of passengers specified for the tour is not met, or for any other reason which renders the tour unfeasible in the sole discretion of Nature Encounters Tours & Travel Ltd. We will not cancel a tour less than 6 weeks prior to departure except for force majeure, or unusual or unforeseen circumstances outside of our control. When a tour is cancelled, Nature Encounters Tours & Travel Ltd. may offer the guest an alternative tour to which the deposit or prepayment may be applied but Nature Encounters Tours & Travel Ltd. will have no obligation to refund any deposit or prepayment. A trip cancellation by Nature Encounters Tours & Travel Ltd. for force majeure will include a cancellation due to any strike, lockout, civil commotion, war-like operation, invasion, rebellion, hostilities, military or usurped power, sabotage, government controls, inability to obtain any materials or services, Act of God, pandemic or other cause beyond the control of Nature Encounters Tours & Travel Ltd.

**4. Travel Documents and medical analysis** - Guests are responsible for arranging and must be in possession of a valid passport, and any visa or vaccination certificates required for the whole of their journey. Information about these matters or related items (climate, clothing, personal gear, baggage etc) is given in good faith but without responsibility on the part of Nature Encounters Tours & Travel Ltd.

Nature Encounters Tours & Travel Ltd. will not provide any medical advice and all guests should arrange a visit with certified medical travel professional. Providing your detailed itinerary will allow your doctor to accurately advise treatments required before, during and after the tour.

## **5. Prices and Surcharges**

Nature Encounters Tours & Travel Ltd. reserves the right to impose surcharges prior to departure due to unfavorable changes in exchange rates, increases in airfares or other transportation costs, taxes or other government action.

## **6. Travel Insurance – Medical Travel insurance is mandatory for all guests for the full duration of the tour.**

This insurance should cover personal accident, medical expenses, air ambulance, loss of effects, repatriation costs and all other expenses that may arise as a result of loss, damage, injury, delay or inconvenience occurring to the guest. Cancellation/Interruption Travel insurance is strongly recommended due to unforeseen circumstances occurring. When the guest has purchased insurance through Nature Encounters Tours & Travel Ltd., the guest acknowledges that they are satisfied with the levels of insurance arranged. When the guest does not take such insurance, they acknowledge that the price of the tour does not include insurance and that they are required to obtain the insurance elsewhere.

Guests making their own arrangements for such insurance should ensure that there is no exclusion clauses limiting protection for the types of activities included in the tour.

**7. Complaints** - Should the guest have a complaint, they must advise the tour leader or ground staff at the time in order that the leader or ground staff can attempt to rectify any problem. Any further complaint must be put in writing within 30 days of the end of the tour.

**8. Tour Participation** - Guests agree to accept the authority and decisions of Nature Encounters Tours & Travel Ltd. employees, tour leaders, ground staff or agents while on tour. If in the opinion of such persons the health or conduct of a guest appears likely to endanger the safe, comfortable or happy progress of a tour, the guest may be excluded from all or part of a tour. The guest must at all times strictly comply with the laws, customs and regulations of all countries visited. Failure to do so could result in the guest being ordered to leave the tour without recourse to any refund.

**9. Nature Encounters Tours & Travel Ltd. Responsibility** - Guest bookings are accepted on the understanding that they appreciate the possible risks inherent in adventure travel and they undertake the tour at their own volition. Due to political and cultural differences, as well as generally tougher physical conditions, adventure travel involves risks other than those we would take in our daily lives. Nature Encounters Tours & Travel Ltd. and our ground operators place extreme importance on the safety of our guests. It is important, however, that guests realize that they are responsible for making themselves aware of the risks involved and of making their decisions accordingly.

No refund will be made for unused services included in the price. Nature Encounters Tours & Travel Ltd. shall not be liable for any delay deviations, omissions from any tour caused by circumstances beyond its reasonable control, nor for any direct or indirect consequences thereto. Nature Encounters Tours & Travel Ltd. shall not be liable to compensate guests for associated expenses incurred as a result of their booking.
